Replace 4160v Gear and MCC at Lower Poplar WWTP Blower Building

This addendum forms a part of the Contract Documents and modifies the original Specifications and Contract Documents as noted below. Acknowledge receipt of this addendum in the space provided on the Bid Form. Failure to do so may result in disqualification of the bidder.

SUMMARY OF PRE-BID CONFERENCE CLARIFICATIONS, QUESTIONS AND RESPONSES

Attached to this Addendum is the Sign In Sheet from the Mandatory Pre-Bid Conference held on Tuesday, July 8, 2025. Clarifications and responses to Questions from the conference are presented as follows:

- QUESTION: Is a Utility Contractors License needed for this project?
 RESPONSE: No, a Utility Contractors License is not needed for this project. General Contractors license will suffice.
- 2) QUESTION: Can the contractor get a digital copy of the plans?
 RESPONSE: Yes, but the Contractor still must purchase a hard copy of the plans to be eligible to bid on the project.
- **3) QUESTION**: There have been many changes and addition to the controls throughout the years. Are the abandoned lines marked?

RESPONSE: Abandoned I/O lines or existing lines that need to be demoed are not marked leaving the existing control Panel The existing I/O devices that MWA wants to keep in service has been identified on the drawings.

- **QUESTION**: Will the work have to be phased? How many temporary blowers will be needed? **RESPONSE**: Yes, the work will need to be phased. The building can be down for no longer than eight hours; however, MWA wants the building and equipment to run as much as possible. There needs to be one (1) temporary large blower.
- **5) QUESTION**: Does the Authority have a specific vendor for the SCADA connections? Will the vendor be working for the Authority or the Contractor?

RESPONSE: Yes, the Authority uses MR Systems, and they will be working for the Contractor.



6) QUESTION: The contract time is 120 days, will MWA be flexible with that time if lead times on equipment are longer than expected?

RESPONSE: Yes, the Authority will take lead times into consideration if a time extension is needed. These will be handled by a request to the Engineer and the Authority will consider and/or approve the request.

7) QUESTION: Will there be any equipment bought ahead of time by the Authority for this project?

RESPONSE: No, the Authority is not providing any equipment or materials for this project.

8) QUESTION: Is MWA dictating what brand of equipment?

RESPONSE: Allen Bradly products for controls. All other equipment shall be as specified or equal.

9) QUESTION: Is the entire room to be painted where the new equipment is going?

RESPONSE: Yes, the entire space is to be painted and cleaned. Colors should be close to what is already in the building.

10) QUESTION: What type of conduit is specified?

RESPONSE: See specification section 260533.13 Part 3.1. PVC below ground incased in concrete. Electrical Rigid Metal Conduit exposed. If in a corrosive environment, Stainless Steel is required.

11) During the Pre-Bid, it was noticed that an abandoned compressed air line was routed in the new electrical space. After discussion with MWA, all compressed air piping and outlets in the new electrical room space shall be removed.
